4. Exhibitors park in designated parking area.
5. Weights only on all 4 corners to secure tent.
6. No electricity available.
7. In order to preserve the quality appearance of shows... All tents must be professionally made (EZUp or better quality) and must have white tops. All tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs.
