- 1. Show Dates:** 2020: NOV. 13-15; 2021: FEB. 26-28 (Limited and select clothing on all shows)
- 2. Show Hours:** Fri., Sat & Sun.: 9a.m. – 5p.m. **Vendors must provide hand sanitizer and masks must be worn at each booth.**
- 3. Booth Fee:** 10x10...\$350. 10x15...\$515. Commercial: add \$75 more. Limited Space. No discounts on 2<sup>nd</sup> & 3<sup>rd</sup> booths if available.
- 4. Setup:** 6a.m.-9a.m. Friday (Thurs 3-5pm \$30 more). **Teardown:** Last day of show after 5pm. **Security:** Thurs, Fri. & Sat nights 5pm-9am
- 5. Separate forms and checks required for each show. Copy this application for additional shows.** **6.** \$50 late fee if not paid 30 days in advance. **7.** No refunds on cancellations 30 days prior to show for any reason. **8.** Checks that are postdated, made out wrong, past deadline, have incorrect fee or no signature will be returned. **9.** \$56 charge on all NSF checks. **10. NO OUT OF STATE CHECKS. LOCAL PHOENIX CHECKS ONLY. NO CHECKS AFTER 30 DAY DEALINE:** cash or certified checks or money orders only... No Exceptions. **11. All exhibitors are required to have a Fountain Hills Business license & IT MUST BE POSTED IN BOOTH. Applications are available at our website or call 480-816-5100. Vendors are responsible for obtaining their license and must show it BEFORE setting up.** **12.** In order to preserve the quality appearance of shows... All tents must be professionally made (EZUp or better quality) and must have WHITE TOPS. All tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs. **13.** Vendors are expected to keep all products, display items and booth materials within the area assigned to them. This includes umbrellas, racks, chairs, tables, signs and anything else associated with the booth. **14.** Bring dollies/carts: no driving into show area. Heavy weights required on all 4 tent legs. No staking. **15.** No water or electricity available. **16.** Unacceptable behavior, not following the rules & misrepresentation of product may result in loss of space and all fees. Swearing, cursing & foul language will not be tolerated. **17. NO PETS or CHILDREN.** **18.** Shows are smoke free: Smoking is not allowed in booths or in show area at any time including during show hours and during setup/teardown. Smokers go outside show area to smoke. No Exceptions. **19.** All shows are alcohol free and drug free, including during setup and teardown. Violations will result in loss of space and removal from show. **20. TRASH** Take ALL trash with you or put in big dumpster in top parking lot. Do not put trash of any kind in small trash receptacles throughout The Plaza. **21. PARKING** Absolutely no vendors vehicles or trailers in either top or lower parking lots...except to setup and tear down. Must be out by 8:45 a.m. each day. Use side streets for parking. **22. INSURANCE: All exhibitors must provide a one million dollar liability certificate naming Dixie Green Promotions as additional insured.**
