Business licenses must be in place 10 days before every show.** 9. No refunds on cancellations 15 days prior to show for any reason 10. Checks that are postdated past deadline, have incorrect fee or no signature will be returned 11. \$56 charge on NSF checks 12. **NO CHECKS AFTER 15 DAY DEADLINE:** cash or certified checks or money orders only... No Exceptions 13. In order to preserve the quality appearance of shows... All tents must be professionally made (EZUp or better quality) and white tents preferred. All tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs. Items and signs not considered appropriate will be removed at the request of promoter. 14. Vendors are expected to keep all products, display items and booth materials within the area assigned to them. This includes umbrellas, racks, chairs, tables, signs and anything else associated with the booth. Items outside the area will be moved at the request of promoter. 15. Bring dollies or carts. 16. Weights and/or stakes required. 17. Unacceptable behavior, not following the rules & misrepresentation of product may result in loss of space and all fees. Swearing, cursing & foul language will not be tolerated. 18. No children. Limited pets on approval & must be kept in your booth. 19.
